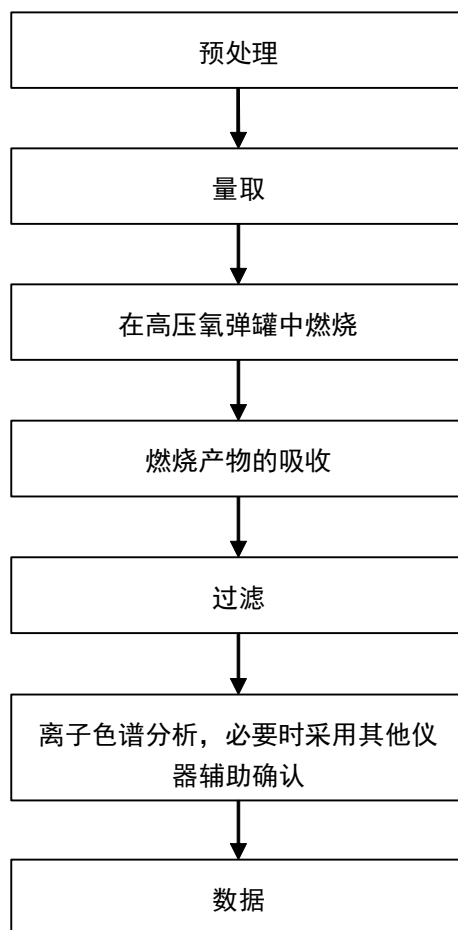

Halogen 测试流程图

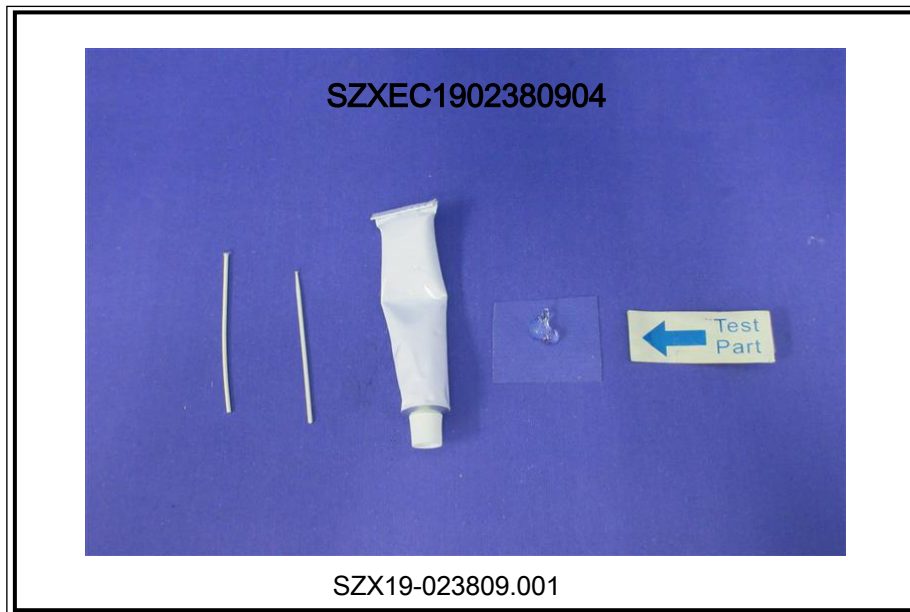
